

Consequences for possession/use of Electronic Devices on School Premises

1. KG-G9:

1st offense: immediate confiscation. Can collect at the end of the next school day. L2 warning on Toddle. School detention (during normal school hours).

2nd offense: immediate confiscation. To be collected by a parent/guardian at the end of the next school day. The parent must sign an undertaking letter. L2 warning on Toddle. Excluded from the next school excursion for their grade.

3rd offense: immediate confiscation. To be collected by a parent/guardian at the end of the next school week. The parent must sign a second undertaking letter. L3 warning on Toddle. Internal school suspension of one day.

4th offense: immediate confiscation. To be collected by a parent/guardian at the end of the next month. The parent must sign a third undertaking letter. L3 warning on Toddle. External school suspension (1 day). No school excursions for the rest of the school year.

5th offense: immediate confiscation. To be collected by a parent/guardian at the end of the next school term. The parent must sign a fourth undertaking letter. L3 warning on Toddle. Longer external school suspension (3 days). Will not be permitted to bring electronic devices to school in G10.

6th offense: immediate confiscation. To be collected by a parent/guardian at the end of the next school term. The parent must sign a fifth undertaking letter. L3 warning on Toddle. Longer external school suspension (5 days). Will not be permitted to bring electronic devices to school in G11 and G12.

7th offense: immediate confiscation. School to consider permanent exclusion.

2. G10-G11:

1st offense: immediate confiscation. Can collect at the end of the next school day. L2 warning on Toddle. School detention (during normal school hours).

2nd offense: immediate confiscation. To be collected by a parent/guardian at the end of the next school day. The parent must sign an undertaking letter. L2 warning on Toddle. Excluded from the next school excursion for their grade.

3rd offense: immediate confiscation. To be collected by a parent/guardian at the end of the next school week. The parent must sign a second undertaking letter. L3 warning on Toddle. Internal school suspension of one day.

4th offense: immediate confiscation. To be collected by a parent/guardian at the end of the next month. The parent must sign a third undertaking letter. L3 warning on Toddle. External school suspension (1 day). No school excursions for the rest of the school year. No school excursions for the rest of the school year.

5th offense: immediate confiscation. To be collected by a parent/guardian at the end of the next school term. The parent must sign a fourth undertaking letter. L3 warning on Toddle. Longer external school suspension (3 days). **Will not be permitted to bring electronic devices to school for the next academic year.**

6th offense: immediate confiscation. To be collected by a parent/guardian at the end of the next school term. The parent must sign a fifth undertaking letter. L3 warning on Toddle. Longer external school suspension (5 days).

7th offense: immediate confiscation. School to consider permanent exclusion.

3. G12:

1st offense: immediate confiscation. Can collect at the end of the next school day. L2 warning on Toddle. School detention (during normal school hours).

2nd offense: immediate confiscation. To be collected by a parent/guardian at the end of the next school day. The parent must sign an undertaking letter. L2 warning on Toddle. Excluded from the next school excursion for their grade.

3rd offense: immediate confiscation. To be collected by a parent/guardian at the end of the next school week. The parent must sign a second undertaking letter. L3 warning on Toddle. Internal school suspension of one day.

4th offense: immediate confiscation. To be collected by a parent/guardian at the end of the next month. The parent must sign a third undertaking letter. L3 warning on Toddle. External school suspension (1 day). No school excursions for the rest of the school year.

5th offense: immediate confiscation. To be collected by a parent/guardian at the end of the next school term. The parent must sign a fourth undertaking letter. L3 warning on Toddle. Longer external school suspension (3 days). **Not permitted to take part in the Senior's Walk.**

6th offense: immediate confiscation. To be collected by a parent/guardian at the end of the next school term. The parent must sign a fifth undertaking letter. L3 warning on Toddle. Longer external school suspension (5 days). **Not permitted to take part in the Seniors' Graduation Ceremony.**

7th offense: immediate confiscation. School to consider permanent exclusion.

During the 2025/2026 academic year, Level 2 (L2) offenses resulted in after-school detention. For the upcoming year, the school proposes moving detentions to the first and second break times. A single L2 offense will incur the loss of four break periods (4 x 20 minutes). Accounting for transition times and purchasing food, these four breaks will yield 60 minutes of net detention time.
